##### **ELIGIBILITY:**

##### **Drop off at OSU Ice Rink:**

1. Both the contract and payment must be submitted to the ice monitor during club ice sessions.

#### **25 % THE OHIO STATE UNIVERSITY STUDENT DISCOUNT:**

##### **ELIGIBILITY:**

1. Skater **MUST** hold a collegiate membership (i.e. CFSC Collegiate Home Club Membership or CFSC Collegiate Non-Home Club Membership).
2. Skater **MUST also** be enrolled in 9 or more credit hours\*\* for the SP 2026 Semester at The Ohio State University.

**\*\*Any membership or credit hour exceptions are at the board's discretion. #### Contract Absences

**PLEASE REVIEW UPDATED POLICY FOR THE WINTER 1 CONTRACT:** To receive credit, please notify the ice chair and the treasurer by submitting the [Contract Ice Absence Form](#) at least 12 hours before the session.

Skaters are allotted **two (2) absences per contracted day**, combined into **one total number of absences allowed** for the contract period. Absences can occur **on any contracted day**. Exceptions are allowed for illnesses and injuries.

- *For example, if a skater contracts club ice sessions on Monday and Sunday, they receive **four (4) total absences** for the contract period. Suppose the skater knows they will be out of town for competitions on **4 of the 8 Sundays** during the Winter 1 Contract Period. The skater may use **all four absences** for those Sundays and will receive credit for each missed session, **if the skater submitted a [Contract Ice Absence Form](#) at least 12 hours before each planned absence.***

Credits will be provided on a **blue punch card**, issued by the Ice Chair. The punch card will reflect only the number of credits earned for missed sessions. These credits may be used for any club ice session. Please note, when using a blue punch card, if a session reaches capacity, the skater's priority will be the same as all other punch-card holders.

#### Late Fee for Payments

A \$25 late fee is charged for payments received more than 10 days after the due date. Returned checks are subject to a \$25 fee. Failure to uphold your financial obligation will affect skater's eligibility to test and compete.

#### Responsibilities and Benefits

1. Receive **credits** toward next ice contract (\$7.50 credit per hour worked).
2. Check in skaters and collect punch card or payment.
3. Enforce safety rules.

#### Ice Monitor Requirements:

All ice monitors must complete a background check and SafeSport Training.

- **New volunteers:** You must complete both before you begin.
- **Returning volunteers:** Please ensure your SafeSport certification and background check are still valid

***Ice monitors must be present at all club ice sessions. Without an ice monitor, Club Ice sessions are at risk of being canceled.***

##### **Can sessions be canceled due to low registration?**

Sessions with low registration may be cancelled. Please retain a copy of the completed application for your records.

##### **Unable to commit to a full contract period?**

Skaters may choose to skate on a **walk-on/stand-by** basis. Before taking the ice, **please check in with the monitor** to check availability and for payment. **Please note**, ice is reserved on a “first come, first served” basis, unless there is a wait list. A maximum of 25 skaters at any given time is permitted. Refer to the website for the skater priority policy in the event a waitlist becomes necessary.

Skaters may pay for walk-on/stand-by ice by:

- **Punch Card (Purchased from the monitor or online via EntryEeze)**
  - Each punch card= **5 total hours of ice (broken into 15-minute increments)**
  - Punch cards **do not expire**, are **non-transferable**, and may be used at the skater’s discretion.
  - Rate: \$90 per 5 hours (equivalent to **\$9.00 per ½ hour**)
- **Cash or Check**
  - Pay the monitor directly.
  - Rate: **\$10.00 per ½ hour**
